**Fees:** A fee of is \$1,600 per day for hearing, research review of evidence and post hearing briefs, and preparation and distribution of decision. A hearing day is any portion of a day up to six hours. Time for research, study and preparation of decision is prorated.

**Expenses:** Neutral charges actual cost of reasonable expenses, including transportation, car rental, food and lodging from Maple Grove, Minnesota. Automobile mileage is charged at the applicable IRS expense rate. Neutral charges actual expenses for copying, phone, postage and clerical. Neutral charges per diem of \$1,600 for any portion of a travel day up to six (6) hours.

**Cancellation Policy:** A cancellation fee of \$1,600 per scheduled hearing date(s) is charged if the parties cancel or continue a hearing within thirty (30) calendar days of the scheduled date(s), or if a continuance is granted from the scheduled hearing date(s) and the case is ultimately resolved without hearing.
