FEE AND EXPENSE PRACTICE:

Arbitration Fees: A basic per diem fee is charged at the rate of \$1,600.00 for each day of hearing, study, or writing. The full per diem fee is charged for all days of hearing. More than one days' per diem may be charged and prorated where the day of hearing and travel extends beyond 9:00 a.m. to 5:00 p.m. Requested pre-hearing services, study and writing which do not take a full day are prorated accordingly. Travel time, which occurs outside the actual day of hearing, is prorated at the per diem rate. All travel expenses are billed from Milwaukee, Wisconsin. Interim billing may be used in cases involving air travel or multiple days of hearing.

Docketing Fee: A \$900.00/day docketing fee is charged for each day docketed in all cases where the case cancels after docketing and is not later heard and decided. If a case is heard and decided, only one \$900.00 docketing fee will be charged. If an additional day of hearing is needed, a \$900.00 docketing fee will be charged for the additional day.

Travel Expenses: All travel expenses including airline, hotel/motel, meals, cabs and rental cars will be billed. Car mileage for personal car will be billed at the IRS rate.

Cancellation Fees: A cancellation fee of \$1,600 plus docketing fee or fees will be charged for any case cancelled thirty-five days or less before the hearing. If a case is scheduled and then cancelled and not re-scheduled and heard, a \$1,600 per diem fee plus docketing fee or fees will be charged when the case is settled/withdrawn. If a hearing is cancelled and then rescheduled, a second docket fee or fees will be charged.

Any fees/charges for cancelled hotel/motel reservations or fees charged by airlines and travel agents for unused tickets are billed to the parties

NOTE: The arbitrator shall not charge any fee other than the above stated fees.
