### DIRECTION OF ELECTION

The above named Petitioner having petitioned the Wisconsin Employment Relations Board to conduct an election pursuant to Section 111.70 of the Wisconsin Statutes, among certain employes of the above named Municipal Employer; and a hearing on such petition having been conducted at Jefferson, Wisconsin on April 19, 1962, the full Board being present; and the Board having considered the evidence and being satisfied that a question has arisen concerning representation for certain employes of the Municipal Employer named above;

NOW, THEREFORE, IT IS DIRECTED that an election by secret ballot shall be conducted under the direction of the Wisconsin Employment Relations Board within sixty (60) days from the date of this Directive in the collective bargaining unit consisting of all regular full-time and regular part-time employes including janitors, firemen, engineers, laundry workers, kitchen and dining room workers, dish washers, nurses aides, attendants, orderlies, maintenance workers and helpers, farm and barn workers in the employ of Jefferson County Hospital and Home and Forest Lawn Home, excluding office employes, registered nurses, licensed practical nurses, craft employes, supervisors and executives, who were employed by the Municipal Employer on May 1, 1962, except such employes as may prior to the election quit their employment or be discharged for cause, for the purpose of determining whether or not a majority of such employes desire to be represented by the above named Petitioner for the purposes of conferences and negotiations with the above named Municipal Employer on questions of wages, hours and conditions of employment.

#### MEMORANDUM ACCOMPANYING DIRECTION OF ELECTION

In the petition filed herein the petitioning labor organization requested to also include among the employes in the appropriate bargaining unit registered nurses, licensed practical nurses and office employes and said labor organization desired to exclude from the unit only the superintendent, the assistant superintendent, the doctor and dentist.

During the course of the hearing the Counsel for the municipal employer raised an objection to the inclusion of the registered nurses, licensed practical nurses and office employes, and further proposed that seventeen employes in addition to the superintendent and assistant superintendent, be excluded from the unit for the reason that they were supervisors.

During the course of the hearing the representative of the petitioner agreed to the exclusion of ten individuals as supervisors and did not agree that registered nurses, licensed practical nurses or office employes should be excluded. Evidence with regard to the issues was adduced during the course of the hearing.

On April 26, 1962, and prior to any further action by the Board, the Board received a communication from the representative of the petitioner, wherein he indicated that the petitioner had changed its position with regard to the issue on eligibles and that it agreed with the position of the municipal employer with regard to the exclusions.

In order that there be no question as to the identity of the employes who are excluded from the bargaining unit, it is noted that, in addition to the superintendent, the assistant superintendent, the doctor and the dentist, the following named employes are not among those eligible to participate in the election.
