DIRECTION OF ELECTIONS

The above named petitioner having petitioned the Wisconsin Employment Relations Board to Conduct an election pursuant to Section 111.70 of the Wisconsin Statutes, among certain employes of the above named Municipal Employer; and a hearing on such petition having been conducted at the City of River Falls,

Wisconsin, on April 30, 1964, James L. Greenwald, Examiner, being present; and the Board having considered the evidence and being satisfied that questions have arisen concerning representation for certain employes of the Municipal Employer;

NOW, THEREFORE it is

DIRECTED

That elections by secret ballot shall be conducted under the direction of the Wisconsin Employment Relations Board within sixty (60) days of the date of this Directive in the following collective bargaining units:

UNIT NO. 1

All regular full-time and regular part-time employes of the City of River Falls employed in its Utility, Sanitation and Street Departments, including working foremen, and excluding temporary employes, supervisors, and confidential and craft employes.

UNIT NO. 2

All linemen employed in the Utility Department of the City of River Falls, excluding supervisors and all other employes.

UNIT NO. 3

All diesel generator operators employed in the Utility Department of the City of River Falls, excluding supervisors and all other employes.

All employes having the classifications which are included as eligibles in the three units described above shall be eligible to participate in the elections if they are in the employ of the Municipal Employer on May15, 1964, except such employes as may prior to the elections quit their employment or be discharged for cause. The purpose of said elections is to determine whether a majority of the employes eligible in each unit described above

desire to be represented by Communication Workers of America for the purpose of conferences and negotiations with the City of River Falls on questions of wages, hours and conditions of employment.

MEMORANDUM ACCOMPANYING DIRECTION OF ELECTIONS

The Union, in initiating this proceeding, filed a single petition wherein it requested the Board to conduct a representation election among "all craft, clerical, foremen and common labor employes of the Utilities Departments and General City" of the City of River Falls. At the hearing it was disclosed that said employes are actually employed in three separate departments of the Municipal Employer, the Utility, Sanitation and Street Departments. The parties stipulated with respect to employes who were confidential and supervisory employes, with the exception as

noted below, and as to their exclusion. The parties also stipulated that employes classified as lineman and diesel generator operators were craft employes. The Union would have included said craft employes in one over-all unit with other eligible employes. The Municipal Employer would have them excluded. Since no issue exists as to the craft status of the lineman and diesel generator operator classifications, the Board must, pursuant to Sec. 111.70 (4) (d) of the Wisconsin Statutes, exclude them from the over-all unit and said employes can only be included in a craft unit consisting of employes performing the same craft work. Although the same provision of the statutes requires separate petitions to be filed for each craft group, the Municipal Employer indicated that it had no objection to the conduct of elections among the employes in separate craft units. Following the hearing and prior to any action by the Board, the Union, in writing, withdrew its objections to separate elections.

At the hearing issues arose concerning the eligibility of three employes to participate in the election involving Unit No. 1. The Municipal Employer would exclude Jim Mertens and Richard Pederson, claiming that they are temporary employes, and further, contends that Donald Johnson should be excluded for the reason of his supervisory status. The Union contends that all three employes should be included among the eligibles.

Generally the Municipal Employer does not consider employes to be regular unless their employment is acknowledged by resolution of the City Council. Mertens, whose employment has not been so acknowledged, was hired in June, 1963 as a laborer in the Street Department for a special building project which was to be completed during that summer. However, Mertens has been retained in employment continuously and has not been given any notification of an early termination. Despite the additional fact that Merten's hourly wage is considerably below that of regular

employes, his employment period has been extended to such an extent that we conclude he is eligible to participate in the election.

Richard Pederson, on the other hand, was hired on April 7, 1964 for a ten-week period and therefore he, as a casual employe, is not eligible to participate in the election.

Donald Johnson, the Street Department Foreman, reports to the Street Commissioner, who is responsible for the operation of the Street Department. Johnson works with and exercises some supervision over the six other employes in the Street Department. Although the City claims Johnson can effectively recommend to the Street Commissioner the hiring and firing of other Street Department employes, he has never had occasion to exercise such authority, and, furthermore, the fact that Johnson receives 17 cents per hour more than the hourly rate paid other regular Street Department employes does not in itself establish such supervisory characteristics so as to exclude him from the eligibles. The Board concludes that Johnson by reason that responsibilities for the overall control and direction of the seven-man Street Department rests with the Street Commissioner, and by reason of Johnson's limited authority and his time spent in work similar to other regular employes, is a working foreman and, as such, shall be included among the eligibles.
