# ORDER AMENDING CERTIFICATION OF REPRESENTATIVES

The Wisconsin Employment Relations Commission having heretofore issued a Certification of Representatives and Order Clarifying Appropriate Collective Bargaining Unit in the above entitled matter, wherein the Wisconsin State Employees Association, Council 24, (and its appropriate affiliated local unions), American Federation of State, County and Municipal Employees, AFL-CIO, was certified as the exclusive collective bargaining representative of all employes of the Department of Public Welfare of the State of Wisconsin, excluding craftsmen (all crafts) and craftsman foreman employed at Wisconsin School for Boys, Wales, Wisconsin, also excluding office clerical employes, professional employes, confidential employes, limited term employes, management employes and supervisory employes; and on August 7, 1968, representatives of the State and said Labor Organization having jointly petitioned the Commission to amend and clarify said certification; and the Commission being fully advised in the premises and being satisfied that the certification should be amended;

NOW, THEREFORE, it is

### ORDERED

That the certification previously issued in the above entitled matter be, and the same hereby is, amended to reflect that the Wisconsin State Employees Association, Council 24, (and its appropriate affiliated local unions), American Federation of State, County and Municipal Employees, AFL-CIO, is the exclusive collective bargaining representative of employes in the following appropriate collective bargaining unit:

All employes of the Department of Health and Social Services of the State of Wisconsin, excluding craftsmen (all crafts) and craftsman foreman employed at Wisconsin School for Boys, Wales, Wisconsin, also excluding office clerical employes, professional employes, confidential employes, limited term employes, management employes and supervisory employes.

# MEMORANDUM ACCOMPANYING ORDER AMENDING CERTIFICATION OF REPRESENTATIVES

Following an election conducted by it, the Commission, on June 9, 1967, certified the Wisconsin State Employees Association, Council 24 (and its appropriate affiliated local unions), American Federation of State, County and Municipal Employees, AFL-CIO, hereinafter referred to as the WSEA, as the exclusive collective bargaining representative of all employes of the Department of Public Welfare of the State of Wisconsin, excluding craftsmen (all crafts) and craftsman foreman employed at Wisconsin School for Boys, Wales, Wisconsin, also excluding office clerical employes, professional employes, confidential employes, limited term employes, management employes and supervisory employes. Subsequently the Commission issued an Order Clarifying the Appropriate Collective Bargaining Unit wherein it made a determination with respect to the inclusion or exclusion of certain positions in the unit. On August 7, 1968, representatives of the State and the WSEA filed a "Petition for Amendment and Clarification of the Certification of Representatives" wherein the parties set forth that, as a result of the Kellett Reorganization Act, Chapter 75, Laws of 1967, the Department of Public Welfare was renamed the Department of Health and Social Services. The Commission is satisfied that the Certification of Representatives should be amended to reflect the change in the name of the department.

Further in said petition the parties set forth that the former State Board of Health was renamed the Division of Health and became a division in the Department of Health and Social Services, and as a result, the employes in said division had become employes of the Department of Health and Social Services. Further in said petition the parties set forth that they had reviewed various classifications employed in the Division of Health and had agreed that the following classifications appeared appropriate for inclusion in the established bargaining unit:

Since the above number of employes is minimal when viewed in light of the results of the representation election previously conducted,  $\frac{2}{}$  and since it appears to the Commission that there would be no basis for establishing the above classifications in the Division

of Health as a bargaining unit separate and apart from the established overall unit in the Department of Health and Social Services, the Commission has amended the certification to reflect the change in the name of the Department of Public Welfare to the Department of Health and Social Services and to include the classifications set forth above in the established collective bargaining unit.
