DIRECTION OF ELECTIONS

Petition having been filed with the Wisconsin Employment Relations Commission by the Wisconsin Nurses Association, Inc., requesting that an election be conducted, pursuant to Section 111.83 of the State Employment Labor Relations Act, in a collective bargaining unit consisting of all regular full-time and regular part-time registered professional nurses in the classified service of the State of Wisconsin, employed by the University of Wisconsin (University Hospitals), Department of Health and Social Services (Public Welfare and Board of Health), Department of Veterans Affairs, Department of Regulation and Licensing (Division of Nurses), Department of Public Instruction, and the State Universities, excluding supervisory personnel and all other employees; and a hearing on such petition having been conducted by the Commission on June 29, July 25, and August 1, 1967, at Madison, Wisconsin; and the Commission having considered the evidence, arguments and briefs of counsel, and being satisfied that the collective bargaining unit sought by the Petitioner is not an appropriate collective bargaining unit; and further being satisfied that such classified employees should be included in separate collective bargaining units consisting of such classified employees employed by the aforementioned separate state agencies, and further being satisfied that questions of representation have arisen concerning the employees in said separate appropriate collective bargaining units;

NOW, THEREFORE, it is

DIRECTED

That elections by secret ballot shall be conducted under the direction of the Wisconsin Employment Relations Commission within ninety (90) days from the date of this directive in the following collective bargaining units for the purpose of determining whether or not a majority of said employees in such separate appropriate collective bargaining units desire to be represented for the purpose of collective bargaining by Wisconsin Nurses Association, Inc.:

Unit No. 1

All regular full-time and regular part-time professional nurses in the employ of the University of Wisconsin (University Hospitals), excluding supervisors, limited-term employees and all other employees, who were employed by said State Employer on January 11, 1968, except such employees as may prior to the election quit their employment or be discharged for cause.

Unit No. 2

All regular full-time and regular part-time professional nurses in the employ of the Department of Health and Social Services (Public Welfare), excluding supervisors, limited-term employees and all other employees, who were employed by said State Employer on January 11, 1968, except such employees as may prior to the election quit their employment or be discharged for cause.

Unit No. 3

All regular full-time and regular part-time professional nurses in the employ of the Department of Health and Social Services (Board of Health), excluding supervisors, limited-term employees and all other employees, who were employed by said State Employer on January 11, 1968, except such employees as may prior to the election quit their employment or be discharged for cause.

Unit No. 4

All regular full-time and regular part-time professional nurses in the employ of the Department of Veteran Affairs, excluding supervisors, limited-term employees and all other employees, who were employed by said State Employer on January 11, 1968, except such employees as may prior to the election quit their employment or be discharged for cause.

Unit No. 5

All regular full-time and regular part-time professional nurses in the employ of the Department of Regulation and Licensing (Division of Nurses), excluding supervisors, limited-

term employes and all other employes, who were employed by said State Employer on January 11, 1968, except such employes as may prior to the election quit their employment or be discharged for cause.

Unit No. 6

All regular full-time and regular part-time professional nurses in the employ of the Department of Public Instruction, excluding supervisors, limited-term employes and all other employes, who were employed by said State Employer on January 11, 1968, except such employes as may prior to the election quit their employment or be discharged for cause.


Unit No. 7




