Dodge County Employees, Local 1323, AFSCME, AFL-CIO, affiliated with Wisconsin Council of County and Municipal Employees, AFSCME, AFL-CIO, having petitioned the Wisconsin Employment Relations Commission to conduct an election pursuant to Section 111.70 of the Wisconsin Statutes among employes of Dodge County Courthouse, Juneau, Wisconsin; and hearing on such petition having been conducted at Juneau, Wisconsin on October 22, 1968, by Byron Yaffe, Hearing Examiner, and the Commission having considered the evidence and arguments of counsel and being satisfied that a question has arisen concerning representation for certain employes of Dodge County Courthouse;

NOW, THEREFORE, it is

DIRECTED

That an election by secret ballot shall be conducted under the direction of the Wisconsin Employment Relations Commission within sixty (60) days from the date of this directive among all regular part-time and regular full-time employes of the Dodge County Court-house, but excluding all elected and appointed personnel, supervisory personnel and confidential and clerical personnel, who were employed by the Dodge County Courthouse on October 22, 1968, except such employes as may prior to the election quit their employment or be discharged for cause for the purpose of determining whether a majority of the eligible employes voting desire to be represented by Dodge

County Employees, Local 1323, AFSCME, AFL-CIO, affiliated with Wisconsin Council of County and Municipal Employees, AFSCME, AFL-CIO, for the purpose of conferences and negotiations with the Dodge County Courthouse on questions of wages, hours and conditions of employment.
