# ORDER CLARIFYING BARGAINING UNIT AND DIRECTION OF ELECTION

On May 18, 1983, the above-named Petitioner filed a petition with the Wisconsin Employment Relations Commission, requesting the Commission to clarify the existing bargaining unit of clerical, food service and building services employes of the above-named Employer by including in that unit some thirty-one employes in six different classifications. The parties subsequently entered into extended negotiations concerning the petition, in the course of which an amended petition to substantially the same effect was filed on January 13, 1984 by the Petitioner. The Petitioner filed a second amended petition, seeking inclusion of some seventy employes in seven classifications, on March 6, 1984. During and after hearing conducted on November 8, 1983 and April 13, 1984 by Examiner Christopher Honeyman the parties entered into a series of agreements concerning clarification of the bargaining unit and an election among residual non-represented employes, and on September 17, 1984 the parties filed with the Commission a joint stipulation of facts agreeing to clarify the bargaining unit and agreeing to the terms of an election among the residual unrepresented employes. Upon the basis of the parties' stipulations, the Commission now makes and issues the following

### ORDER CLARIFYING BARGAINING UNIT

Pursuant to the parties' stipulation, the following clerk, clerk-typist, custodial and cafeteria positions are unconditionally included in the bargaining unit represented by District Council 48, AFSCME, AFL-CIO, and its Affiliated Local 587. The current positions and employes occupying these positions are:

Also upon the basis of the parties' stipulation, the Commission makes and issues the following

## **DIRECTION OF ELECTION**

An election by secret ballot shall be conducted under the direction of the Wisconsin Employment Relations Commission within forty-five (45) days from the date of this directive in the residual unit consisting of all part-time Evening School Center Clerk/Campus Center Secretary employes, excluding all managerial employes, supervisory employes, confidential employes, employes currently represented and all other employes, who were employed on October 30, 1984, except such employes as may prior to the election quit their employment or be discharged for cause, for the purpose of determining whether the required number of such employes desire to be represented by District Council 48, AFSCME, AFL-CIO and its affiliated Local 587, or by no representative, for the purposes of collective bargaining with the Milwaukee Area Board of Vocational, Technical and Adult Education District No. 9.

# MEMORANDUM ACCOMPANYING ORDER CLARIFYING BARGAINING UNIT AND DIRECTION OF ELECTION

The stipulation of facts filed by the parties in this matter reads in pertinent part as follows:

1. On January 6, 1984, a petition for unit clarification was filed by Milwaukee District Council 48, AFSCME, AFL-CIO, and its Affiliated Local 587, seeking to include in a bargaining unit certified by the Wisconsin Employment Relations Commission on December 2, 1968 in Case III, No. 12399, Decision 8739, ME 407, the following positions:

Part-time Clerks (approximately 18);
Part-time Clerk-Typists (approximately 4);
Part-time Food Service Utility Workers
(Approximately 3);
Part-time Food Service Workers (approximately 4);
Registrations Records Supervisor (one)

2. On or about February 29, 1984, the above-named petitioner filed an amended petition seeking to include in the certified unit the above-described employees, and in addition, the following positions:

Part-time Evening School Center Clerks/Campus Center Secretary (approximately 39).

- 3. On April 13, 1984, at the time and place scheduled for the hearing on the petition for unit clarification, the parties met and reached a stipulation of facts as hereinafter set forth.
- 4. The parties agree that employees who work in temporary registration related positions, whether in the registration department or elsewhere, solely during "peak periods" and who perform no other work performed by bargaining unit employees shall be excluded from the unit as casual or temporary employees, but that those employees who work beyond the "peak periods" shall be accreted into the bargaining unit if they satisfy the "minimum hours" test defined below.
  - 4a. The "peak periods" during which such casual or temporary employees may be scheduled to work are defined as follows:

The period beginning four working weeks before the start of the first school year semester through three working weeks after the start of the first school year semester, and the period five working weeks before the start of the second school year semester through three working weeks after the start of the second school year semester.

- 4b. The following current employees shall be accreted to the unit on the basis of their scheduled performance of work performed by bargaining unit employees beyond the "peak periods" defined above and in excess of the "minimum hours" defined below:

5a. The "minimum hours" test shall be determined as follows:

Employees who do not perform more than 250 hours of work performed by bargaining unit employees during any six-month period shall be regarded as casual employees and shall not be accreted into the unit. Employees who exceed 250 hours of work performed by bargaining unit employees in any six-month period shall be accreted into the bargaining unit and shall remain in the bargaining unit thereafter. The six month period shall not be limited to a calendar year. The Union shall receive a semi-annual report of all said employees in the months of June and December for all hours worked in the previous six (6) month period.

5b. The following current employees shall be accreted into the bargaining unit based on the "minimum hours" test:

The parties agree that the following clerk, clerk-typist, custodial and cafeteria positions originally included within the ambit of the 1968 WERC certification, as amended, noted above, and within the scope of the parties' recognition clause in their collective bargaining agreement shall be accreted into the bargaining unit represented by District Council 48, AFSCME, AFL-CIO, and its Affiliated Local 587. The parties agree that the Union has not previously requested inclusion in the bargaining unit of employees holding the position of part-time Evening School Center Clerk/Campus Center Secretary, and the parties therefore agree that an election should be directed for employees holding such positions, said election to be limited to the question of whether such employees elect no Union or elect to be included in the bargaining unit represented by District Council 48, AFSCME, AFL-CIO, and its Affiliated Local 587. We find that the above-noted terms of inclusion and exclusion agreed to by the parties are not repugnant to the purposes and policies of MERA, and we therefore adopt the stipulation, and clarify the bargaining unit and direct an election accordingly.

If the residual bargaining unit of part-time Evening School Center Clerks and Campus Center Secretaries elect to be represented by the Petitioner, the unit involved herein shall be merged with the existing collective bargaining unit of non-professional employes. Terms and conditions of any existing collective bargaining agreement, however, shall not automatically be applied to employes in the residual unit unless collective bargaining produces such a result. 1/
