DIRECTION OF ELECTION

Local 587, District Council #48, AFSCME, AFL-CIO, having filed a petition with the Wisconsin Employment Relations Commission to conduct an election pursuant to Section 111.70 of the Wisconsin Statutes, among certain employes of Milwaukee Technical College; and a hearing on such petition having been conducted at Milwaukee, Wisconsin, on October 21, 1968, by Howard S. Bellman, Examiner; and the Commission, having considered the evidence, being satisfied that a question has arisen concerning representation of certain employes of the Municipal Employer named above;

NOW, THEREFORE, it is

DIRECTED

That an election by secret ballot shall be conducted under the direction of the Wisconsin Employment Relations Commission within thirty (30) days from the date of this Directive in the collective bargaining unit consisting of all employes of the Milwaukee Technical College classified as Clerk I, II, III, IV; Stores Clerk I, II, III; Clerk-Typist I, II, III; Clerk-Stenographer I, II, III, IV; Administrative Assistant and Secretary; Student Service Coordinator I; Keypunch Operator I, II; Telephone Operator; Machinist-Repairman; Maintenance Worker I, II, III; Assistant Stage Manager;

Security Officer; Engineering Aid; Foundry Helper; Custodial Worker I, II, III; Public Service Assistant; Audio-Visual Aids Assistant; Bindery Assistant Trainee and Bindery Assistant I, II, excluding supervisory personnel, craft employes, professional employes, technical employes, confidential employes and student-interns subsidized by federal funds, who were employed by the Municipal Employer on October 21, 1968, except such employes as may prior to the election quit their employment or be discharged for cause, for the purpose of determining whether or not a majority of such employes desire to be represented by Local 587, District Council #48, AFSCME, AFL-CIO, for the purposes of conferences and negotiations on questions of wages, hours and conditions of employment.

MEMORANDUM ACCOMPANYING DIRECTION OF ELECTION

The collective bargaining unit described in the attached Direction was proposed by the Petitioner. The Municipal Employer neither approved nor disapproved thereof and proposed no other unit.

The Municipal Employer reserved the right to challenge the ballots of employes in the Machinist-Repairman and Maintenance Worker III classifications on the ground that they are craft employes and to challenge the ballots of employes in the Clerk-Stenographer IV, Clerk IV and Student Service Coordinator I classifications on the ground that they are supervisory employes.

The parties stipulated that employes Margaret Chelhar, Elizabeth Thier and Marion Weyer, who are in the Administrative Assistant and Secretary classification; employes Bonnie Boase, Karyn Zehren, who are in the Clerk-Stenographer III classification and employe Judith Lukas, who is in the Clerk-Stenographer I classification, are ineligible to vote because they are either supervisory or confidential employes.
