MEMORANDUM ACCOMPANYING ORDER OF CLARIFICATION

On January 21, 1969, Technicians, Engineers and Architects of Milwaukee County, hereinafter referred to as the Petitioner, was certified by the Commission, after an election conducted by it, as the collective bargain representative of all

"Engineers, Engineering Technicians III, IV, and V, Architects, Landscape Architects, Architectural Draftsmen, Design Draftsman, Estimator and Specification Writer as included within the Engineering Group defined in Section 17.32(2) of the General Ordinances of Milwaukee County, excluding all other employes which are in currently certified bargaining units and exluding all other employes, supervisory employes, confidential employes and executives."1/

In its present petition, Petitioner requested clarification as to whether the classification of Construction Superintendent and Draftsman III (Civil Engineer) should be included in the above collective bargaining unit. All interested parties were given notice of a scheduled hearing, but at the request of the parties the hearing was indefinitely postponed to permit the parties to execute a stipulation with respect to the petition. On September 28, 1970, the Commission received the following stipulation executed by representatives of the Patitioner, Milwaukee County, and Milwaukee District Council 46, AFSCME,

AFL-CIO, 2/ and the Petitioner. Said stipulation provided as follows:

"IT IS HEREBY STIPULATED AND AGREED by and between the Technicians, Engineers and Architects of Hilwaukee County (TEAHCO), the petitioner herein, Milwaukee County, the employer, and Hilwaukee County District Council #48, AFSCME, AFL-CIO, that the newly created position of Draftsman III (Civil Engineer) should be included in the existing collective bargaining unit presently represented by said Petitioner and that the existing position of Construction Superintendent, previously excluded from the petitioning organization as supervisory, should be included in such existing collective bargaining unit for the reason that changes in duties of that position reflect the fact that the Construction Superintendent does not supervise other County employes, but rather, supervises and inspects work done by outside contractors.

"IT IS FURTHER STIPULATED AND AGREED that the unit certification of the petitioner be clarified in accordance with the above stipulation."

In view of the above stipulation, the Commission is today issuing and Order of Clarification, reflecting that the classification of Construction Superintendent and Draftsman III (Civil Engineer) should be included in the above described collective bargaining unit represented by the Petitioner.
