ORDER DENYING PETITION FOR REHEARING

On May 9, 2002, the Wisconsin Employment Relations Commission issued Findings of Fact, Conclusion of Law and Order Clarifying Bargaining Unit in the above matter wherein the Commission concluded that the Walworth County Zoning Officers are not professional employees within the meaning of Sec. 111.70(1)(L), Stats.

On May 29, 2002, Walworth County filed a petition for rehearing pursuant to Sec 227.49, Stats., asserting that the Commission erred when it concluded that the Zoning Officers were not professional employees. The County asserts the Commission erroneously concluded that the knowledge needed to perform the work of the Zoning Officer is not customarily acquired through a prolonged course of specialized intellectual instruction and study in an institution of higher education.

On June 7, 2002, Walworth County Courthouse Employees, Local 1925B, AFSCME, AFL-CIO filed a statement in opposition to the petition.

We have considered the petition and conclude that we did not make a material error of law or fact when we determined that the Zoning Officers are not professional employees. As stated in our decision, we remain persuaded that "the knowledge provided by a four year specialized degree is 'desirable' but not 'required' to do the Zoning Officer's work."
