STIPULATION

WHEREAS:

1. In number 4773 Valley Sanitation Company, Inc. (herein called Employer) petitioned the Court for review of portions of a decision and order of the Wisconsin Employment Relations Commission; (herein called Commission)

2. In number 5181 The Wisconsin Employment Relations Commission petitioned the Court for enforcement of the same order;

3. Drivers, Salesmen, Warehousemen, Milk Processors, Cannery, Dairy Employees and Helpers Local Union No. 695 (herein called Union) moved the Court on February 20, 1973 to intervene in numbers 4773 and 5181 as an interested party;

4. Employer, Commission and Union have reached a settlement of the matters in controversy in numbers 4773 and 5181;

THEREFORE, the parties, by their respective counsel, agree:

1. Employer will pay Union and Romaine G. Smith, jointly, the sum of -\$4,500.00- in full settlement of any and all damages and any other claims either Union or Romaine G. Smith may have against Employer arising out of the subject matter of numbers 4773 and 5181.

2. The Commission and the Union acknowledge that Employer has, upon execution of this stipulation and making payment as provided herein, complied with the Commission's order which was sought to be enforced in number 5181, and the Commission's order shall be deemed complied with.

3. Employer does not admit to having violated any law.

4. Union does not disclaim interest in representing employees of Employer, but acknowledges that to claim recognition it would need a new demonstration of majority in an appropriate unit.

5. Commission, Union and Employer may each enforce this stipulation against the other parties by application to this Court.

6. The Court may, upon filing by any party of a receipt for \$4,500.00 signed by Romaine G. Smith and Drivers, Salesmen, Warehousemen, Milk Processors, Cannery, Dairy Employees and Helpers Local Union No. 695; and upon motion of any party, and without further or other notice to any party, approve this stipulation and dismiss Nos. 4773 and 5181 with prejudice and without costs subject to the parties' rights under paragraph 5 hereof.
