ORDER DISMISSING PETITION FOR DECLARATORY RULING

Menasha Professional Policemen's Association, through its representative, Gordon Myse, filed a petition requesting the Wisconsin Employment Relations Commission to issue a declaratory ruling to determine whether sergeants and captains should be included or excluded in the bargaining unit of police personnel covered by the existing collective bargaining agreement between it and the City of Menasha; and the Commission having scheduled a hearing on said petition for December 7, 1971, at Menasha, Wisconsin; and said Petitioner having advised the Commission on December 6, 1971, that the Petitioner and City had agreed that said petition ought to be dismissed pursuant to a settlement agreement reached between the parties; and the Commission being satisfied as a result of such agreement that no declaratory ruling is necessary in the instant matter.

NOW, THEREFORE, it is


ORDERED


That the petition filed herein be, and the same hereby is,  
dismissed.



Prior to the hearing the Petitioner and the City of Menasha reached a settlement wherein it was agreed that captains would be excluded from the collective bargaining unit of police personnel as supervisors and that sergeants should be included in the collective bargaining agreement provided the Petitioner was able to produce satisfactory evidence that said sergeants desired to be represented by the Petitioner. The parties agreed that an informal election, to be conducted by George R. Fleischli, a Mediator on the Commission's staff, would be acceptable as satisfactory evidence of the desires of the sergeants. Pursuant to that agreement an informal election was conducted on December 7, 1971, wherein a majority of said sergeants indicated their desire to be represented by the Petitioner.
