ORDER CORRECTING MEMORANDUM ACCOMPANYING
ORDER DISMISSING PETITIONS

The Wisconsin Employment Relations Commission heretofore and on April 17, 1972, issued an Order Dismissing Petitions filed in the above entitled matters as well as a Memorandum accompanying same; that the Commission stated, in part, as follows:

"Case XXXVI

The Petitioner seeks a unit of employees in the Physical Plant Divisions of the UW-Madison and in that regard would also include the classifications involved in Cases XXXII and XXXIII. The majority of the classifications employed in the Physical Plant Divisions are 'blue collar' positions. 2/ However, since there are a number of other 'blue collar' type positions which are employed in the Physical Plant Divisions, the Commission deems that the employees employed in the Physical Plant Divisions are not an appropriate unit."

and the Commission now being satisfied that the quoted language does not accurately reflect the facts involved;

NOW, THEREFORE, it is

ORDERED

That that portion of the Memorandum referred to above be, and the same hereby is, amended to read as follows:

"Case XXXVI

The Petitioner seeks a unit of employees in the Physical Plant Divisions of the UW-Madison and in that regard would also include the classifications involved

in Cases XXXII and XXXIII. The majority of the classifications employed in the Physical Plant Divisions are 'blue collar' positions. 2/ However, since there are a number of other 'blue collar' type positions which are employed in divisions other than those employed in the Physical Plant Divisions, the Commission deems that the employees employed in the Physical Plant Divisions are not an appropriate unit."
