DIRECTION OF ELECTION

Leona Bodmer having petitioned the Wisconsin Employment Relations Commission to conduct an election pursuant to Section 111.70, Wisconsin Statutes, among certain employes of the City of Appleton employed as crossing guards; and a hearing on such petition having been conducted on May 18, 1971, at Appleton, Wisconsin, by Herman Torosian, Hearing Officer; and the parties during the course of the hearing having agreed to the unit appropriate for collective bargaining; and the Commission being satisfied that a question has arisen concerning representation for certain employes of the above named Municipal Employer;

NOW, THEREFORE, it is


DIRECTED

That an election by secret ballot shall be conducted under the direction of the Wisconsin Employment Relations Commission within sixty (60) days from the date of this Directive in the bargaining unit consisting of all crossing guards employed by the City of Appleton, but excluding supervisors and all other employes of the Employer who were employed by the City of Appleton on March 29, 1972, except such employes as may prior to the election quit their employment or be discharged for cause for the purpose of determining whether a majority of such employes desire to be represented by General Drivers and Dairy Employees Union Local No. 563, for the purposes of conferences and negotiations with the above named Municipal Employer on questions of wages, hours and conditions of employment.



MEMORANDUM ACCOMPANYING DIRECTION OF ELECTION

The instant petition was filed by the Petitioner, Leona Bodmer, on January 19, 1971, claiming that certain employes in the City of Appleton crossing guard unit no longer desired General Drivers and Dairy Employees Union Local No. 563 to represent them in negotiations on wages, hours and conditions of employment.


Subsequently, on March 16, 1971, and before hearing in the matter, a complaint was filed by Local No. 563 against the City of Appleton, Alderman Robert Roemer and Leona Bodmer, a crossing guard, alleging certain prohibited practices, which complaint could affect the validity of the instant petition. Both matters were heard on May 18, 1971. During the course of the hearing, in the instant matter, the parties stipulated that should the Examiner dismiss Complainant's complaint and find that a question of representation exists, that the appropriate collective bargaining unit should consist of all crossing guards employed by the City of Appleton, but excluding supervisors and all other employes of the Municipal Employer.

On December 21, 1971, the Examiner dismissed Complainant's complaint against Respondents City of Appleton, Robert Roemer and Leona Bodmer. Such decision was affirmed by the Commission 1/ and as stipulated by the parties, a question of representation exists and therefore an election has been directed.


