The above entitled matter having come on for hearing on the 11th day of December, 1972, at which time it was heard before the court without a jury, Dennis J. Flynn, Corporation Counsel, appearing for the petitioner, Racine County, and Charles D. Hoornstra, Assistant Attorney General, appearing on behalf of the respondent, Wisconsin Employment Relations Commission, and the court having heard the arguments and considered the briefs of counsel and being duly advised in the premises, and having taken the matter under advisement and having on the 25th day of July, 1973, filed its written decision in this matter;

NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that the order of the Wisconsin Employment Relations Commission entered on the 14th day of July, 1972, be, and the same hereby is, confirmed and enforced, the court reserving jurisdiction to make such further order or judgment in the premises as may be necessary to give full force and effect to the order of the Commission and the enforcement thereof on the evidence in the record or on the taking of such further evidence as appears to the court to be necessary, the present judgment and decree of the court to be deemed interlocutory as to those matters that may call for or require further action on the part of the court.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Petitioner, Racine County, its officers and agents, shall immediately

1. Cease and desist from refusing to bargain collectively with the Racine County Deputy Sheriffs' Association concerning the payment of wage increases retroactively to the termination date of the 1971 collective bargaining agreement between Racine County and the Racine County Deputy Sheriffs' Association.

2. Take the following affirmative action which will effectuate the policies of the Municipal Employment Relations Act:

a. Upon request, bargain collectively with the Racine County Deputy Sheriffs' Association as the exclusive representative of all employees in the aforesaid appropriate unit, with respect to the payment of wage increases for 1972 retroactive to the termination date of the 1971 collective bargaining agreement between Racine County and the Racine County Deputy Sheriffs' Association.

b. Notify the Wisconsin Employment Relations Commission in writing within thirty (30) days from notice of this order and judgment as to what steps have been taken to comply herewith.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the petition of Racine County for Review of the order of the Commission dated July 14, 1972, be, and the same hereby is, dismissed.
