ORDER DISMISSING PETITION FOR UNIT CLARIFICATION

The State of Wisconsin having, on September 30, 1980, filed a petition requesting the Wisconsin Employment Relations Commission to clarify an existing collective bargaining unit consisting of security and public safety employees in its employ, which unit was and is represented by Wisconsin State Employees Union (WSEU), Council 24, AFSCME, AFL-CIO; and the facts material to the disposition of the issues involved herein having been elicited at a hearing on a complaint of unfair labor practices filed by WSEU, which hearing was held on October 8, 1980, at Madison, Wisconsin, Chairman Morris Slavney and Commissioner Gary Covelli being present; and the parties having thereafter filed briefs in the matter; and the Commission having reviewed the record and briefs of Counsel, and being fully advised in the premises, makes and issues the following

ORDER

That the petition filed herein be, and the same hereby is, dismissed.


MEMORANDUM ACCOMPANYING ORDER DISMISSING PETITION

The subject matter of the instant petition concerned issues which were directly involving in the complaint and declaratory ruling proceedings, and said issues have been disposed of in the decision of the Commission rendered today in the complaint case. 1/ Therefore, we refer the parties to said decision, and we see no reason to add anything further to this Memorandum, other than to state that the petition filed herein has been dismissed.


