ORDER DISMISSING PETITION FOR UNIT CLARIFICATION

On March 23, 2001, Robert Schlotthauer, a mortician employed by the State of Wisconsin, filed a petition to clarify bargaining unit with the Wisconsin Employment Relations Commission asserting that he and two other morticians are ". . . licensed, degreed professionals included in a blue collar bargaining unit, and wish to join a union of our peers."

On April 16, 2001, Local 171 and Council 24, Wisconsin State Employees Union filed a motion to dismiss the petition because existing Commission precedent requires that such petitions be filed by either a labor organization or by the employer.

By letter dated April 18, 2001, the Commission invited Schlotthauer and the State to respond to the motion to dismiss.

On April 25, 2001, the State filed a statement in support of the motion to dismiss. Schlotthauer subsequently filed a statement in opposition to the motion.

We have long held that a petition for unit clarification can only be filed by a labor organization or the State. STATE OF WISCONSIN, DEC. NO. 13824 (WERC, 7/75); STATE OF WISCONSIN, DEC. NO. 11245-P (WERC, 3/94). Consistent with that precedent, we are persuaded this petition should be dismissed because it was filed by employees.

NOW, THEREFORE, it is

ORDERED

The petition for unit clarification is dismissed.
