ORDER AND JUDGMENT

The above entitled matter having come on for hearing on the 10th day of December, 1973, before the court without jury, upon the petition of the Wisconsin Employment Relations Commission for enforcement of a certain order pursuant to sec. 111.07 (7), Stats., and Charles D. Hoornstra, Assistant Attorney General, appearing for the petitioner, Teamsters Local 43 appearing by Thomas J. Kennedy, Esq., for Goldberg, Previant & Uelmen, and the respondent not appearing at all except that Lester Ludwig, respondent's President, advised the court by telephone prior to said hearing that a physical disability prevented him from appearing in person, and

The respondent not having filed a petition for review of said order of the commission within the time set forth in sec. 111.07 (8) and sec. 227.16, Stats., and not having otherwise appeared except as noted above, and therefore being in default, and

The court being fully advised in the premises,

Now, therefore, on motion of the said Charles D. Hoornstra,

IT IS ORDERED, ADJUDGED AND DECREED that the order of the Wisconsin Employment Relations Commission, entered on the 6th day of July, 1973, in the matter of "Teamsters, Chauffeurs and Helpers, Local No. 43, Complainant, vs. Obenauf-Geneva Services, Inc., Respondent, Case II No. 16028 Ce-1443, Decision No. 111335-B," be, and the same hereby is, confirmed and enforced, the court reserving jurisdiction to make such further order or judgment in the premises as may be necessary to give full force and effect to the order of the commission and the enforcement thereof on the evidence in the record or on the taking of such further evidence as appears to the court to be necessary, the present judgment and decree of the court to be deemed interlocutory as to those matters that may call for or require further action on the part of the court.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the respondent Obenauf-Geneva Services, Inc., its officers and agents, shall immediately:

1. Cease and desist from refusing to execute the collective bargaining agreement reached by the parties on December 27, 1972 and subsequently reduced to writing.

2. Take the following affirmative action to effectuate the policies of the Wisconsin Employment Peace Act:

- a. Immediately execute the collective bargaining agreement existing between complainant and respondent.

- b. Notify the commission within twenty (20) days of service of notice of entry of this judgment and order of the action taken to comply herewith.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this order and judgment shall be personally served on Lester Ludwig, respondent's President, and that this order and judgment cannot be enforced until the expiration of ten days from service of notice of entry thereof, and that within said ten days the respondent may petition this court to reopen this order and judgment on the basis of a proper defense in law or in fact.
