MEMORANDUM ACCOMPANYING
ORDER DENYING MOTION


The City of Milwaukee seeks an adjournment of a hearing scheduled by the Commission for November 7, 1972, on a petition filed by the Milwaukee Police Supervisors Organization requesting an election to determine what, if any, representation police supervisory personnel in the employ of the City of Milwaukee desire, pursuant to Section 111.70(3)(b)5.(d).

The City's Motion for adjournment was filed with the Commission on November 3, 1972.

On November 1, 1972, the City filed a petition with the Commission requesting that the Commission change certain of its rules reflected in the Wisconsin Administrative Code, specifically relating to ERB 17.01, 17.02, 17.04 and 17.07. The Commission sees no valid reason to delay the hearing with respect to the petition filed by the Milwaukee Police Supervisors Organization. In addition to taking evidence with respect to the petition filed by the latter organization requesting an election among supervisory police personnel in the employ of the City of Milwaukee, during the course of said hearing the Commission will afford the parties, and other parties having an interest or those who may be affected by the rules involved, an opportunity to be heard with respect to the City's petition for changes in said rules.
