ORDER AFFIRMING EXAMINER'S FINDINGS OF FACT,
CONCLUSIONS OF LAW AND ORDER

Examiner George R. Fleischli having, on June 14, 1974, issued Findings of Fact, Conclusions of Law and Order, with Accompanying Memorandum, in the above entitled matter, wherein he found that the above named Respondents had committed certain prohibited practices within the meaning of Sections 111.70(3)(a)4 and 111.70(3)(a)1 of the Municipal Employment Relations Act and wherein he found that the above named Respondents had not committed a violation of the collective bargaining agreement existing between the parties, and in that regard that the Respondents had not committed a prohibited practice within the meaning of Section 111.70(3)(a)5 of the Municipal Employment Relations Act; and further with respect to the acts found to be violative of the Municipal Employment Relations Act said Examiner ordered said Respondents to cease and desist from such prohibited activity and to take specific affirmative action to remedy the prohibited practices found to have been committed; and neither of the parties having timely filed a petition for review of said Examiner's Findings of Fact, Conclusions of Law and Order, with Accompanying Memorandum; and on the contrary, on July 5, 1974, Counsel for the Respondents having, in writing, advised the Commission that it was taking steps to comply with the Order issued by the Examiner; and the Commission being satisfied that the Findings of Fact, Conclusions of Law and Order, with Accompanying Memorandum, issued by the Examiner be affirmed;

NOW, THEREFORE, it is

ORDERED


That, pursuant to Section 111.07(5) of the Wisconsin Statutes, the Wisconsin Employment Relations Commission hereby adopts the Examiner's Findings of Fact, Conclusions of Law and Order, with Accompanying Memorandum, issued in the above entitled matter as its Findings of Fact, Conclusions of Law and Order, with Accompanying Memorandum.


