IT IS ORDERED that judgment be entered for the petitioner, The Board of the Western Wisconsin Vocational, Technical and Adult Education District, a municipal employer with its principal offices located at Sixth and Vine Streets, LaCrosse, Wisconsin, and against the respondent, Wisconsin Employment Relations Commission, an agency of the State of Wisconsin with its principal offices located at 30 West Mifflin Street, Madison, Wisconsin, denying the respondent's motion to dismiss and granting the relief requested in the petitioner's petition for judicial review of the respondent's order set forth in the penultimate paragraph of the Memorandum Accompanying Order Dismissing Petition in WERC Decision No. 12257-C because said order is a nullity in that it was made and promulgated upon improper procedure, but without prejudice to said order insofar as it dismisses the election petition and without prejudice to the respondent's findings of fact, conclusions of law, order and memorandum accompanying the same, the same being dated August 2, 1974, and identified as the respondent's decision number 12355-B.
