STIPULATION

It is hereby stipulated and agreed that the above entitled action may be dismissed, with prejudice and without costs, upon the following terms and conditions:

1. Respondent Don Cvetan, Sr., d/b/a Don Cvetan Plumbing, shall pay to David Schmitz the sum of \$500.00 wages, less proper withholding of Social Security, State and Local tax.

2. Respondent shall pay to Local Union 206 the sum of \$3,500.00, in full settlement of all obligations owed by Respondent to Local 206 up to and through June 15, 1975. Such sum shall be allocated in order of priority and to the extent funds are available, as follows:

A. Union Assessment

B. Industry & Development Fund

C. Education Fund

D. Pension Fund, prorated to the accounts of Don Cvetan, Jr., Mike Cvetan and David Schmitz.

3. In the event David Schmitz does not join the Union by January 1, 1976, all pension benefits accrued to his benefit shall be forfeited to the accounts of Don Cvetan, Jr., and Mike Cvetan.

4. Commencing June 15, 1975, Respondent will comply with all the terms and conditions of the collective bargaining agreement between Respondent and Local 206, incorporating the wage rate and fringe benefit contributions as bargained by Local 206 and the East Central Wisconsin Plumbing & Heating Contractors Association.

It is further stipulated that initiation fees of \$425.00 for Don Cvetan, Jr., and Mike Cvetan and \$175.00 for David Schmitz have been paid by Respondent and received by Local 206.
