ORDER OF DISMISSAL

The Wisconsin Employment Relations Commission heretofore and on June 7, 1974, having issued a Direction of Elections in the above entitled matters, wherein the Commission, among other things, directed elections to be held among six separate voting groups to determine the desires of employes therein with respect to appropriate bargaining units; and on July 26, 1974, the Commission having initially conducted an election among the voting group consisting of all regular full-time and all regular part-time Registered Nurses, in the employ of the above named Employer, to determine whether they desired to constitute a unit separate and apart from other employes employed in the Nursing Service Department of the Employer, and wherein a majority of said nurses rejected constituting said nurses as a separate unit; and thereafter the Commission having scheduled unit determination votes among employes employed in the remaining five voting groups for August 2, 1974; and prior to any further action by the Commission, the above named Petitioner, on July 31, 1974, having, in writing, requested to withdraw its petitions; and the Commission being satisfied that the results of the unit vote conducted among registered nurses be set aside, and that the petitions initiating the instant proceedings be dismissed;

NOW, THEREFORE, it is

ORDERED

That the results of the unit vote conducted among all regular full-time and all regular part-time Registered Nurses in the employ of Trinity Memorial Hospital of Cudahy, Inc. be, and the same hereby is, set aside, and further, that the petitions initiating the instant matters be, and the same hereby are, dismissed.

MEMORANDUM ACCOMPANYING ORDER OF DISMISSAL

The Petitioner, in writing, requested to withdraw its petitions filed in the instant matters on the basis that the National Labor Relations Act has been amended so as to cover non-profit institutions. It indicated that it intended to file petitions with the National Labor Relations Board to determine the question of representation existing among employes of the instant Employer.

While the Petitioner in its letter indicated "the NLRA has been amended so that the NLRB now has jurisdiction over private non-profit hospitals" the Commission is aware that the amendment to the National Labor Relations Act, involved herein, does not become effective until August 26, 1974, and, therefore, it is dismissing the petitions solely on the request of the Petitioner and not on the basis that the Commission, at this time, has no jurisdiction in the matters. Such loss of jurisdiction will occur on August 26, 1974, when the involved amendment becomes effective.
