The undersigned parties to this action by their respective counsel hereby consent and agree as follows, namely:

1. WHEREAS this action arises out of a determination by the respondent based upon certain findings of fact and conclusions of law which related to an underlying collective bargaining agreement between Ladish Co. - Tri-Clover Division and Office & Professional Employees International Union Local #336 in a proceeding captioned before the Wisconsin Employment Relations Commission being Case XXXIV No. 18600, Ce-1577;

2. WHEREAS subsequent to the determination in said matter by the Wisconsin Employment Relations Commission and subsequent to the institution of this action, Ladish Co., Tri-Clover Division and Office & Professional Employees International Union Local #336 have agreed to compromise and settle the matters which were the subject of said proceeding before the Wisconsin Employment Relations Commission and this Court; and

3. WHEREAS this action and the underlying proceeding before the Wisconsin Employment Relations Commission involves no principle of statewide concern but rather involves the interpretation of a contractual provision of a collective bargaining agreement in a precise factual setting;

NOW THEREFORE the parties hereto hereby consent and agree to the entry of the subjoined order herein without further notice and upon motion of either party.

ORDER

Upon the above and foregoing stipulation of the parties hereto, IT IS
HEREBY ORDERED:

1. The decision of the Wisconsin Employment Relations Commission herein be and the same hereby is vacated;

2. This matter is hereby remanded to the Wisconsin Employment Relations Commission which is directed to enter its order dismissing the complaint herein;

3. This order is the result of a settlement agreement entered into between Ladish Co., Tri-Clover Division and Office & Professional Employees International Union Local #336 and therefore the order of this court and the action taken by the Wisconsin Employment Relations Commission pursuant thereto as well as the decision of the Wisconsin Employment Relations Commission on appeal to this court shall not be considered as precedent between Ladish Co., Tri-Clover Division and Office & Professional Employees International Union Local #336 for any purpose; rather, the said Ladish Co., Tri-Clover Division and Office & Professional Employees International Union Local #336 shall in respect of all matters before this court and before the Wisconsin Employment Relations Commission herein rely upon the settlement agreement entered into between those entities;

4. No costs are allowed to either party.
