ORDER AFFIRMING EXAMINER'S FINDINGS OF FACT, CONCLUSION OF LAW AND ORDER

Examiner Amedeo Greco having, on December 19, 1975, issued his Findings of Fact, Conclusion of Law and Order, with Accompanying Memorandum, in the above entitled proceedings wherein the above named Respondents were found to have committed unfair labor practices within the meaning of Section 111.06(1)(a) and (c)la [now (c)l] of the Wisconsin Employment Peace Act by terminating Jerome Meltzer and Dana Schneider because of their union activities, and wherein the Respondents were ordered to cease and desist therefrom and to take certain affirmative action with respect thereto; and thereafter said Respondents having timely filed a petition with the Wisconsin Employment Relations Commission requesting that the Commission review the Examiner's decision pursuant to Section 111.07(5) of the Wisconsin Employment Peace Act; 1/ and the Commission, having reviewed the evidence and arguments presented before the Examiner, The Examiner's decision and the petition for review, and being fully advised in the premises, being satisfied that the Findings of Fact, Conclusion of Law and Order, with Accompanying Memorandum, issued by the Examiner should be affirmed;

NOW, THEREFORE, it is

The Respondents failed to specify in said petition what aspects of the Examiner's decision the Respondents were dissatisfied with.

ORDERED

That, pursuant to Section 111.07(5) of the Wisconsin Employment Peace Act, the Wisconsin Employment Relations Commission hereby adopts the Examiner's Findings of Fact, Conclusion of Law and Order, with Accompanying Memorandum, issued in the above entitled matters as its Findings of Fact, Conclusion of Law and Order, with Accompanying Memorandum, and, therefore, the Respondents, Wayne Mosley and Roger Brown, Rocky Rococo Corporation, shall notify the Wisconsin Employment Relations Commission within ten (10) days of the receipt of a copy of this Order as to what steps they have taken to comply therewith.
