DIRECTION OF REFERENDUM

Brewery Workers Local Union No. 9, D.A.L.U., AFL-CIO, having petitioned the Wisconsin Employment Relations Commission to conduct a referendum among certain employes of Southeastern Wisconsin Products Company, Inc., Milwaukee, Wisconsin; and a hearing on such petition having been conducted on July 21, 1975, at Milwaukee, Wisconsin; and the Commission having considered the evidence and being satisfied that a question has arisen concerning an "All-Union Agreement" for certain employes of the above Employer;

NOW, THEREFORE, it is

DIRECTED

That a referendum by secret ballot shall be conducted under the direction of the Wisconsin Employment Relations Commission in the collective bargaining unit consisting of all production and maintenance employes at the Employer's Milwaukee, Wisconsin location, excluding laboratory employes, quality control employes, office-clerical employes, guards and supervisors as defined in the Act, who were employed by Southeastern Wisconsin Products Company, Inc. on August 15, 1975, except such employes as may prior to the referendum quit their employment or be discharged for cause, for the purpose of determining whether the required number of such employes favor an "All-Union Agreement" between the Employer and the Union named above.

MEMORANDUM ACCOMPANYING DIRECTION OF REFERENDUM

During the course of the hearing evidence was adduced to establish that 24 employes were actively employed in the unit. Their names appear in the attachment hereto marked as Exhibit A and identified as employes actively employed as of August 15, 1975. Also during the course of the hearing an issue arose as to 9 employes who were laid off on June 27, 1975, and July 11, 1975. Their names appear on Exhibit B attached hereto and marked "Personnel on Layoff." The parties stipulated that the employes listed on Exhibit B, at least as of August 15, 1975, had no expectancy of returning to employment, and, therefore, should not be eligible to participate in the referendum. However, the parties further agreed that any employes listed on Exhibit B who are, in fact, recalled and actively employed as of the date of the referendum, shall be eligible to vote.
