DIRECTION OF ELECTION

Northwest United Educators having on September 19, 1975, filed a petition with the Wisconsin Employment Relations Commission requesting the Commission to conduct an election among certain employes of Cooperative Educational Service Agency No. 4, to determine whether such employes desired to be represented for purposes of collective bargaining; and hearing in the matter having been held at Barron, Wisconsin on October 8, 1975, by Robert M. McCormick, Hearing Officer being present, and the Commission having considered the evidence and arguments of the parties and being satisfied that a question has arisen concerning representation for certain employes of the above named Municipal Employer;

NOW, THEREFORE, it is

DIRECTED

That an election by secret ballot be conducted under the direction of the Wisconsin Employment Relations Commission within sixty (60) days from the date of this Directive in the collective bargaining unit consisting of all regular full-time and regular part-time non-professional employes in the employ of Cooperative Educational Service Agency No. 4, excluding coordinator, supervisors, confidential employes and professional employes, who were employed by said Municipal Employer on December 10, 1975, except such employes as may prior to the election quit their employment or be discharged for cause, for the purpose of determing whether such employes desire to be represented by Northwest United Educators for the purposes of collective bargaining with the Municipal Employer on questions of wages, hours and conditions of employment.

MEMORANDUM ACCOMPANYING DIRECTION OF ELECTION

At outset of hearing, the Municipal Employer, by counsel, submitted a list of claimed eligibles which included the names of eight employes, Joyce Moriak, Janet Bortels, Shirley Jangerberg, Ruth Kittleson, Jerry McGinius, Alice Swanson, Steve Harrington and Bonnie Wistroill, which the Municipal Employer contended were employed by a separate entity, Northwest Joint Education Cooperative and which the Municipal Employer did not employ.

The Petitioner argues that the Municipal Employer advanced the same argument in an election proceeding before the Commission affecting professionals in the winter of 1974, and then abandoned said contention and honored the Commission's Certification of Representatives. 1/

The parties further indicated at hearing that they were not prepared to litigate the matter of the relationship between Northwest Joint Education Cooperative and the Municipal Employer; and that no representative of the aforementioned entity was present to make a record as to the alleged employe-employer relationship between Northwest Joint Education Cooperative and the eight aforementioned non-professional employes.

The parties stipulated: that the Commission should direct an election and conduct same among employes in the stipulated bargaining unit and include on its official eligibility list the names of the eight employes, supra; that in the event any of said employes presented themselves to vote, that the Commission-agent take their ballots on challenge by the Municipal Employer; and that only in the event such challenged ballots should affect the results of the vote, should the Commission schedule a hearing on the challenged ballots and determine which entity is in fact the employer of such employes.

The Commission shall conduct the election under said condition and will construct the eligibility list accordingly and so instruct its agent conducting the balloting.
