ORDER GRANTING IN PART AND DENYING IN PART MOTIONS TO MAKE MORE DEFINITE AND CERTAIN AND ORDER DENYING MOTIONS TO STRIKE

Racine Education Association, herein Association, having filed a prohibited practices complaint with the Wisconsin Employment Relations Commission, herein Commission, wherein it alleged that Racine Unified School District No. 1, herein the District, had committed certain prohibited practices; and the District having thereafter filed separate complaints against the Association adn James Ennis, Susan Griego, Alan Pirk and Jay Newell; and the foregoing complaints having been consolidated for hearing; and the Commission having appointed Amedeo Greco, a member of the Commission's staff, to act as hearing Examiner in the matter; and the Association and James Ennis, Susan Griego, Alan Pirk and Jay Newell having thereafter filed motions to make more definite and certain and motions to strike, and the District having opposed said motions; and the Examiner having considered the matter;

NOW, THEREFORE, it is

ORDERED

That the motions to make the complaints more definite and 1. certain filed in the above-entitled matter be, and the same hereby are, granted in part, and that therefore said amended complaints specify: (1) the time of the alleged acts referred to in paragraphs 4(c) and (f) of the two complaints filed by the District, including the names of the individuals involved in said acts; and (2) the specific acts referred to by the phrase "other acts" which is contained in paragraphs 5 of said complaints, including the time and the perpetrators of said acts.

That the District need not furnish any further requested 2. information.

That the motions to strike are denied in their entirety. 3.

That the information noted in paragraph (1) supra should be 4. filed by the District with the Commission, with a copy to Respondent, by April 21, 1976.

MEMORANDUM ACCOMPANYING ORDER GRANTING IN PART AND DENYING IN PART MOTIONS TO MAKE MORE DEFINITE AND CERTAIN AND ORDER DENYING MOTIONS TO STRIKE

Inasmuch as District has failed to specify with sufficient clarity the acts and times referred to in paragraphs 4 (c) and (f) of its separate complaints, as well as the perpetrators of said acts, the District is required to provide said information, pursuant to ERB rules 12.02(2) and 12.03(3). Similarly, and for the same reasons, the District is required to specify what acts, if any, are included under the phrase "other acts" in paragraph 5 of the complaints, including the time and perpetrators of said acts. 1/

On the other hand, since the complaint does state with sufficient clarity the other allegations herein, the remaining requests to make , more definite and certain are hereby denied. The motions to strike are also denied as the issues raised therein primarily go to the merits of the case and the legal conclusions to be drawn therefrom.

Additionally, the District has requested that "in the event the Examiner grants keepondents' motions", that it be accorded by opportunity to take depositions and that the scheduled hearing be postponed. Such requests are hereby denied as the District has failed to show good cause as to why such depositions are needed.
