ORDER AMENDING FINDINGS OF FACT AND ORDER

The undersigned on June 14, 1977 having issued Findings of Fact, Conclusions of Law and Order in the above-entitled matter; and Finding of Fact number 12 having provided, inter alia, that "in schools which consisted of only non Association members, only Association members in the past voted in such elections", and said finding having been incorrect; and said Order having provided that the Racine Education Association should cease and desist from "Encouraging employes to engage in any unauthorized work stoppages;" and said Order having been incorrectly phrased; and the Examiner having considered the matter pursuant to Section 111.07(5) and (6) of the Wisconsin Employment Peace Act;

NOW, THEREFORE, it is hereby

ORDERED

1. That Finding of Fact number 12 in the above-entitled matter, be hereby amended to provide that:

No. 14389-E
No. 14390-E

"in schools which consisted of only Association members, only Association members in the past voted in such elections."

2. That the order is hereby amended to provide that the Racine Education Association is hereby directed to cease and desist from:

"Encouraging employees to engage in any unauthorized work stoppages in violation of the contractual no-strike prohibition."
