MEMORANDUM ACCOMPANYING ORDER AFFIRMING EXAMINER'S FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

3. That the findings are contrary to law."

The Commission has reviewed the record and concludes that the Examiner's Findings of Fact were not based upon assumptions and conjecture not in the record but, to the contrary, that the Examiner's Findings of Fact and his Conclusions of Law are supported by the evidence adduced during the course of the hearing. Therefore, we have affirmed the Examiner's decision, as well as his Memorandum Accompanying same.
