ORDER GRANTING MOTION TO MAKE
COMPLAINT MORE DEFINITE AND CERTAIN

Northwest United Educators, herein Complainant, having filed a complaint with the Wisconsin Employment Relations Commission alleging that School District of New Auburn and Douglas A. Walker, herein Respondents, have committed certain prohibited practices; and the Commission thereafter having appointed Peter G. Davis, a member of the Commission's staff, to act as Examiner in the matter; and the Respondent having subsequently filed a motion to make the complaint more definite and certain; and the Examiner having considered the matter;

NOW, THEREFORE, it is

ORDERED

1. That the motion to make the complaint more definite and certain in the above-entitled matter be, and the same hereby is, granted, and that therefore the Complainant shall clarify its complaint by specifying the following:
 - (a) With respect to paragraph V subparagraph (f) of said complaint: which individual members of the New Auburn Professional Bargaining Unit did Respondent Walker meet, when did such meetings occur, and what specific statements were made by Respondent Walker in connection with his alleged attempt to "persuade them to the Board of Education offer."
 - (b) With respect to paragraph V subparagraph (g) of said complaint: which individual members of the New Auburn Professional Bargaining Unit did Respondent Walker attempt to individually negotiate items, when and where did these alleged negotiations take place, and what conduct or statements of Respondent Walker allegedly constituted such negotiation.
 - (c) With respect to paragraph V subparagraph (h) of said complaint: which individual teachers were threatened, when and where did said threats occur, what were the specific threats allegedly made by Respondent Walker and to which Union activities did such alleged threats refer.

- (d) With respect to paragraph V, subparagraph (i) of said complaint: to whom did Respondent Walker make the alleged offers, when and where were said offers made, and what was the nature of the alleged offers.
- (e) With respect to paragraph V, subparagraph (j) of said complaint: which New Auburn teachers were threatened by Respondent Walker, when and where did such threats occur, what was the nature of the threats, who were the New Auburn teachers collectively threatened, when did said threats occur, and what was the exact nature of said threats.

2. That this information shall be filed by the Complainant with the Commission, a copy to Respondents, by January 11, 1977.
