NOTICE OF COMMISSION'S FINDINGS OF FACT, CONCLUSIONS  
OF LAW AND ORDER PURSUANT TO SECTION 111.07(5), STATS.

Examiner Thomas L. Yaeger having, on December 1, 1981, issued his Findings of Fact, Conclusions of Law and Order, with Accompanying Memorandum, in the above-entitled proceedings, wherein the above-named Respondent was found to have committed, and was committing, a prohibited practice within the meaning of Sections 111.70(3)(a)4 and 1 of the Municipal Employment Relations Act, and wherein the Respondent was ordered to cease and desist therefrom and to take certain affirmative action with respect thereto; and thereafter, on December 2, 1981, the Examiner having, on his own motion, issued an Order Modifying Examiner's Order; and no petition for review of said decision, as amended, having been filed within the twenty day statutory period set forth in Section 111.07(5), Stats.; and no further order having been issued by the Examiner or the Commission within said statutory period;

NOW, THEREFORE, the Commission issues the following

That by operation of Section 111.07(5), Stats., Examiner Yaeger's Findings of Fact, Conclusions of Law and Order, as amended on December 2, 1981, became the Commission's Findings of Fact, Conclusions of Law and Order on December 22, 1981, and, therefore, the Respondent, Board of School Directors of Milwaukee, is hereby required to notify the Wisconsin Employment Relations Commission within ten (10) days of the date of this Notice as to what steps it has taken to comply therewith.
