ORDER GRANTING MOTION TO MAKE
MORE DEFINITE AND CERTAIN

Northwest United Educators, herein NUE, having filed objections with the Wisconsin Employment Relations Commission, herein Commission, wherein it alleged that Bloomer Joint School District No. 1, herein the District, had interfered with the conduct of a representation election held on March 30, 1977; and the Commission thereafter having appointed Amedeo Greco, a member of its staff, to act as Hearing Officer in the matter; and the District having thereafter filed a motion to make more definite and certain; and the NUE having responded to said motion; and the Hearing Officer having considered the matter;

NOW, THEREFORE, it is

ORDERED

1. That the motion to make more definite and certain in the above-entitled matter be, and the same hereby is granted and that therefore the objections specify:
 - (a) The content of the mailbox flyers and the alleged "misleading and inaccurate" representations contained therein, alluded to in paragraph 1 of the objections;
 - (b) The dates and places of the meetings alluded to in paragraph 2 of the objections, as well as who was present at such meetings and the nature of the "negotiable items" discussed.
 - (c) As to paragraph 3 of the objections, the dates and places of such meetings, how such meetings were closed, what matters of "negotiations" and "representation" were discussed, and why such meetings were indicative of the "preferred status" of the rival labor organization.
 - (d) The name of the teacher who was supposedly threatened and interrogated in paragraph 4 of the objections, and the date place, and nature of such interrogation and threats.
 - (e) The nature of the advice alluded to in paragraph of the objections, when, where, and to whom such advice was given, and why such advice constituted dominance and interference.

2. That this information must be filed by the NUE with the Commission, with a copy to the District, by May 9, 1977.
