ORDER GRANTING MOTION TO MAKE MORE DEFINITE AND CERTAIN

Milwaukee District Council 48, AFSCME, AFL-CIO, and Nick Ballas, Staff Representative, herein Complainants, filed a complaint with the Wisconsin Employment Relations Commission against Wisconsin Humane Society, herein Respondent, alleging that Respondent has committed certain unfair labor practices; the Commission thereafter appointed Ellen J. Henningsen, a member of the Commission's staff, to act as Examiner in the matter; Respondent subsequently filed a timely motion to make the complaint more definite and certain; the Examiner has considered the matter and is satisfied that the motion should be granted;

NOW, THEREFORE, it is

ORDERED

1. That the motion to make more definite and certain filed in the above-entitled matter is granted and that therefore Complainants shall amend their complaint so as to clarify paragraph six by specifying:

- a) whether the June Dzemske mentioned in paragraph six is the same person as "one of Complainant's negotiating committee members" also mentioned in paragraph six;
- b) whether the intimidating and coercive statements allegedly made by Albert P. Keller to June Dzemske are the only alleged recriminatory and discriminatory actions complained of in paragraph six and, if not, what other actions allegedly taken by Albert P. Keller on April 27, 1977 against one of Complainant's negotiating committee members were recriminatory and discriminatory and the name of said member;
- c) what allegedly intimidating and coercive statements were made by Albert P. Keller to June Dzemske.

2. That such information must be filed by Complainants with the Commission, with a copy to Respondent, on or before October 20, 1977.

3. That Respondent may file an answer to the amended complaint with the Commission, with a copy to Complainants, on or before October 27, 1977.

4. That the hearing in this matter will be held on October 31, and November 1, 1977, as previously scheduled.

MEMORANDUM ACCOMPANYING ORDER GRANTING

Therefore, the Examiner has required Complainants to provide such specificity. Absent a showing of good cause, failure to supply such information on or before October 20, 1977 shall be grounds for dismissal of that portion of the complaint.
