ORDER TO MAKE COMPLAINT MORE DEFINITE AND CERTAIN

Nasser Nahavandi, herein Complainant, having filed separate complaints with the Wisconsin Employment Relations Commission alleging that UniServ-North, WinnebagoLand, Mr. Henry Krokosky, Executive Director (Fox Valley Technical Institute Faculty Association) and Fox Valley Technical Institute, herein Respondents, have committed unfair labor practices under the State Employment Labor Relations Act; and the Commission thereafter having appointed Peter G. Davis, a member of the Commission's staff, to act as Examiner in said matter; and the Examiner having consolidated the complaints for the purposes of hearing; and the Examiner having determined that said complaints did not include a statement of specific statutory sections which have allegedly been violated by Respondents; and the Examiner having therefore ordered that Complainant file amended complaints which set forth the statutory section(s) which Respondents have allegedly violated; and Complainant having, on August 28, 1978, filed amended complaints which again failed to specifically set forth the statutory section(s) allegedly violated by Respondents;

NOW, THEREFORE, it is

ORDERED

1. That Complainant file amended complaints before September 18, 1978, which specifically set forth the statutory section(s) which Respondents have allegedly violated.

2. That until said amended complaints are filed with the Examiner, the instant matter will not be set for hearing.
