ORDER GRANTING MOTION TO MAKE
COMPLAINT MORE DEFINITE AND CERTAIN

Nasser Nahavandi, herein Complainant, having filed separate complaints with the Wisconsin Employment Relations Commission alleging that UniServ-North, WinnebagoLand, Mr. Henry Krokosky, Executive Director (Fox Valley Technical Institute Faculty Association), and Fox Valley Technical Institute, herein Respondents, have committed unfair labor practices under the State Employment Labor Relations Act; and the Commission having thereafter appointed Peter G. Davis, a member of its staff, to act as Examiner in said matters; and the Examiner having consolidated the complaints for the purposes of hearing and ordered Complainant to file amended complaints specifying the specific statutory sections allegedly violated by the Respondents; and Complainant having, on September 19, 1978, filed amended complaints alleging that Respondents had committed certain specific prohibited practices under the Municipal Employment Relations Act; and Respondent Fox Valley Technical Institute having on October 13, 1978 filed a motion to make complaint more definite and certain; and Complainant having taken no position with respect to said motion; and the Examiner having considered said motion;

NOW, THEREFORE, it is

ORDERED

1. That the motion to make complaint more definite and certain in the above-entitled matter be, and the same hereby is, granted; and that Complainant shall therefore clarify its complaint against Fox Valley Technical Institute by specifying the following:

- (a) The names of those persons who allegedly treated the complainant unequally in regard to promotions, wages and conditions of employment.
 - (b) The times and places in which these alleged instances of unequal treatment took place.
 - (c) Which actions by Respondent Fox Valley Technical Institute are allegedly in violation of Wisconsin Statutes, Section 111.70(3)(a)(1).
 - (d) The specific provisions of the collective bargaining agreement which were allegedly violated by Respondent Fox Valley Technical Institute giving rise to the allegation of a violation of Wisconsin Statutes, Section 111.70(3)(a)(5).
 - (e) The facts and circumstances upon which the allegation of a violation of Wisconsin Statutes, Section 111.70(3)(a)(5) is made.
2. That this information shall be filed by the Complainant, a copy to Respondent Fox Valley Technical Institute, by November 16, 1978.
3. That Respondent Fox Valley Technical Institute shall then file its answer by November 27, 1978.
