ORDER DENYING MOTION TO MAKE COMPLAINT MORE DEFINITE AND CERTAIN

Nasser Nahavandi, herein Complainant, having filed separate complaints with the Wisconsin Employment Relations Commission alleging that UniServ-North, Winnebagoland, Mr. Henry Krokosky, Executive Director (Fox Valley Technical Institute Faculty Association) and Mr. David Nance, and Fox Valley Technical Institute, herein Respondents, have committed unfair labor practices under the State Employment Labor Relations Act; and the Commission having thereafter appointed Peter G. Davis, a member of its staff, to act as Examiner in said matters; and the Examiner having consolidated the complaints for the purposes of hearing and ordered Complainant to file amended complaints specifying the specific statutory sections allegedly violated by the Respondents; and Complainant having, on September 19, 1978, filed amended complaints alleging that Respondents had committed certain specific prohibited practices under the Municipal Employment Relations Act (MERA); and Respondent Fox Valley Technical Institute having on October 13, 1978 filed a motion to make complaint more definite and certain; and the Examiner having granted said motion on October 30, 1978; and Complainant having filed an amended complaint in response thereto on November 30, 1978; and hearing having been held in the above-entitled matters on December 5, 1978 and December 6, 1978 during which Complainant represented himself and orally amended both his complaint against Respondent Uni-Serv-North et al. to allege prohibited practices under Sections 111.70(3)(b)1, 2, 3, 4 and 5 of MERA as well as his complaint against Respondent Fox Valley Technical Institute to allege prohibited practices under Section 111.70(3)(a)1, 2, 3, 4, 5 and 6 of MERA; and Respondent Fox Valley Technical Institute having on December 13, 1978
