ORDER AND JUDGMENT

The above entitled matter having come on for hearing before the court on the 4th day of February, 1981, at 11:00 a.m. in Circuit Court Branch 3 of the LaCrosse County Courthouse, upon the petition of the Wisconsin Employment Relations Commission for enforcement of its findings of fact, conclusions of law and order issued September 26, 1979 (decision No. 16520-B) which adopted and affirmed the examiner's findings of fact, conclusions of law and order with accompanying memorandum dated September 4, 1979 (Decision No. 16520-A); petitioner, Wisconsin Employment Relations Commission, appearing by Bronson C. La Follette, Attorney General, and John D. Niemisto, Assistant Attorney General; respondent Del Kraus, president, d/b/a Del Kraus, Incorporated, having made no appearance; and the court having considered the matter upon the record and having on the 4th day of February, 1981, in open court, rendered its decision orally now, on motion,

IT IS ORDERED AND ADJUDGED that the findings of fact, conclusions of law and order of the Wisconsin Employment Relations Commission, entered on September 26, 1979, which adopted the examiner's findings of fact, conclusions of law and order dated September 4, 1979, in the above entitled matter are hereby confirmed, the court reserving jurisdiction to make such further order or judgment in the premises as may be necessary to give full force and effect to the said order of the Commission and the enforcement thereof.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the respondent Del Kraus, president, d/b/a Del Kraus, Inc., shall immediately comply with the terms and conditions of the stipulation entered into by respondent on October 16, 1978; and more specifically, that respondent comply with paragraphs 2, 3, and 4 of said stipulation, namely:

(2) That the respondent shall make payments to the complainant [Laborers' International Union of North America-Local No. 140] or shall present evidence that he has made payment to the complainant, of those sums provided for in the collective bargaining agreement covering payments to the health and welfare pension funds of the Wisconsin Laborers; said sum shall be for the period from June 27, 1977 through June 27, 1978.

(3) That the respondent shall provide to the complainant evidence of the hourly rates of pay and the number of hours worked for the one-year period from January 27, 1977 through June 27, 1978 for all employees covered by the collective bargaining agreement employed by respondent.

(4) That the respondent shall comply with all monetary provisions of the collective bargaining agreement from the period of June 1, 1978 through October 16, 1978 (the date of the pre-hearing conference in the above-entitled matter.)

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the respondent shall notify the Wisconsin Employment Relations Commission and this court in writing, within twenty (20) days following the date of this order and judgment as to what steps have been taken to comply herewith.
