

O R D E R

The above-entitled consolidated proceedings were commenced in January 1983, to review a decision and order of the Wisconsin Employment Relations Commission under the Wisconsin Employment Peace Act; and

Evco Plastics having appeared by Paul A. Hahn and Michael G. Stuart, Boardman, Suhr, Curry & Field, and Local No. 1406 having appeared by William Haus, Kelly, Haus & Katz, and the Commission having appeared by David C. Rice, Assistant Attorney General; and

The court having reviewed the record and having had the benefit of written argument of the parties; and


The court having filed its memorandum decision on July 11, 1983, wherein the court determined that the Commission acted

correctly in all respects except that it erred (1) in that its conclusion concerning Paul Kozlowski's qualifications as a mold maker in May, 1978 is without a sufficient evidentiary basis, and (2) in failing to consider whether Kozlowski was qualified for any other position filled by Evco Plastics between January and September 1978;

Now therefore, IT IS ORDERED that the decision and order of the Commission are affirmed in all respects except as they relate to Paul Kozlowski, and the matter is remanded to the Commission for further proceedings consistent with the court's memorandum decision.
