ORDER TO AMEND COMPLAINT TO MAKE
MORE DEFINITE AND CERTAIN


United Electrical, Radio and Machine Workers of America (UE) Local 1132, and John Ferreira, herein Complainants, having, on August 22, 1979, filed a complaint of unfair labor practices with the Wisconsin Employment Relations Commission, wherein they allege that Peter Cooper Corporations, U.S. Glue and Gelatin Division, herein Respondents, have committed certain unfair labor practices; and the Commission, on August 29, 1979, having appointed James D. Lynch, a member of the Commission's staff, to act as Examiner in the matter; and Complainants having on September 26, 1979 moved for an order requiring the Complainant to make its complaint more definite and certain, and the Examiner having, on September 26, 1979, granted said motion; and the Wisconsin Administrative Code, Section ERB 2.02(c) requires that a complaint of unfair labor practices shall contain a clear and concise statement of facts constituting said unfair labor practices; and the Examiner finding said complaint being so indefinite as to not be in compliance with the aforesaid requirement makes and issues the following

ORDER

That Complainants, on or before October 4, 1979, make their complaint at paragraph 5 more definite and certain by stating with specificity those facts alleged to constitute unfair labor practices within the meaning of Section 111.06, Stats., including the time and place of occurrence of particular acts.


MEMORANDUM ACCOMPANYING ORDER TO AMEND
COMPLAINT TO MAKE MORE DEFINITE AND CERTAIN

The undersigned intends by this Order that, inter alia, such particulars with respect to alleged acts referred to in paragraph 5 set forth in the amended complaint as required by Wisconsin Administrative Code, Section ERB 22.02(c) on or before October 4, 1979. Respondent is hereby granted an extension of time in which to file his answer until October 11, 1979.
