ORDER DISMISSING PETITION FOR REVIEW AND  
NOTICE OF COMMISSION'S FINDINGS OF FACT, CONCLUSIONS  
OF LAW AND ORDER PURSUANT TO SECTION 111.07(5), STATS.

Examiner William C. Houlihan having, on November 27, 1979, issued his Findings of Fact, Conclusions of Law and Order, with Accompanying Memorandum, in the above-entitled proceeding, wherein the above-named Respondent was found to have committed prohibited practices within the meaning of Section 111.70(3)(a)5 of the Municipal Employment Relations Act by violating the collective bargaining agreement, in certain respects, existing between it and the Complainant, and wherein the Examiner ordered the Respondent to cease and desist from such violations and to take certain affirmative action to remedy same; and the Respondent having, on December 14, 1979, timely filed a petition with the Wisconsin Employment Relations Commission to review said Examiner's decision pursuant to the provisions of Section 111.07(5), Stats.; and thereafter, and by May 1, 1980, Counsel for the parties having filed briefs with regard to the petition for review; and prior to any further action by the Commission, and on June 16, 1980, the Respondent having advised the Commission, in writing, that the parties have entered into a settlement agreement in the matter providing, among other things, that the Respondent would withdraw its petition for review and that the Examiner's decision would become the Commission's decision by operation of Section 111.07(5), Stats.; and the Commission, on the basis of said settlement agreement, being satisfied that the petition for review should be dismissed and the Examiner's decision should become the Commission's decision;

NOW, THEREFORE, it is

ORDERED

That the petition for review filed in the above-entitled matter be, and the same hereby is, dismissed, and further, that, by operation of Section 111.07(5), Stats., Examiner Houlihan's Findings


