JUDGMENT

The above entitled proceeding having come on for hearing before the court, the Honorable P. Charles Jones, presiding, on November 21, 1980; and

The Wisconsin Employment Relations Commission having appeared by David C. Rice, Assistant Attorney General, and the respondent having failed to appear; and

The Commission having moved for a judgment confirming and enforcing its order in International Union of Operating Engineers Local No. 139 v. Larson Landscape, Inc., WERC Dec. Nos. 17474 and 17475; and

The court having determined, pursuant to sec. 111.07(7), Stats., that the Commission's motion should be granted,

NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED:

(1) That the order of the Wisconsin Employment Relations Commission in International Union of Operating Engineers Local No. 139 v. Larson Landscape, Inc., WERC Dec. Nos. 17474 and 17475; be, and the same hereby is confirmed.

(2) That Larson Landscape Service, Inc., its successors and assigns, shall immediately:

a. Cease and desist from violating the provisions of the collective bargaining agreement in effect between it and the International Union of Operating Engineers Local Union No. 139 relating to wage and benefits payments and submission of unresolved grievances to final and binding arbitration.

b. Take the following affirmative actions:

i) Immediately make payment by certified check to the order of David Hoffman in the amount of \$157.08 and mail same to International Union of Operating Engineers Local Union No. 139, at 420 South Park Street, Madison, Wisconsin 53715, as the remitting agent for improper wage payments due and owing as a result of Hoffman's employment by Larson Landscape, Inc.

ii) Immediately make payment by separate certified checks to the order of: (1) the International Union of Operating Engineers Central Pension Fund in the amount of \$18.00; (2) Operating Engineers Local 139 Health Benefit Fund in the amount of \$21.00; and (3) Operating Engineers Local 139 Skill Improvement and Apprenticeship Fund in the amount of \$1.00, and mail same to International Union of Operating Engineers Local Union No. 139 at 420 South Park Street, Madison, Wisconsin 53715, as the remitting agent for delinquent benefit payments due and owing as a result of Hoffman's employment by Larson Landscape, Inc.

iii) Immediately make payment by certified check to the order of Tim Goeden in the amount of \$1,644.52 and mail same to International Union of Operating Engineers Local Union No. 139 at 420 South Park Street, Madison, Wisconsin 53715, as the remitting agent for improper wage payments due and owing as a result of Goeden's employment by Larson Landscape, Inc.

iv) Immediately make payment by separate certified checks to the order of: (1) International Union of Operating Engineers Central Pension Fund in the amount of \$325.80; (2) Operating Engineers Local 139 Health Benefit Fund in the amount of \$380.10; and (3) Operating Engineers Local 139 Skill Improvement and Apprenticeship Fund in the amount of \$18.10, and mail same to International Union of Operating Engineers Local Union No. 139 at 420 South Park Street, Madison, Wisconsin 53715, as the remitting agent for delinquent benefit payments due and owing as a result of Goeden's employment by Larson Landscape, Inc.

v) Notify the Wisconsin Employment Relations Commission, in writing, within twenty (20) days following the date of this judgment as to what steps have been taken to comply herewith.
