NOTICE OF COMMISSION'S FINDINGS OF FACT, CONCLUSIONS
OF LAW AND ORDER PURSUANT TO SECTION 111.07(5), STATS.

Examiner Stuart S. Mukamal having, on May 18, 1981, issued his Findings of Fact, Conclusions of Law and Order, with Accompanying Memorandum, in the above-entitled consolidated proceedings, wherein the City of Cudahy was found to have committed, and was committing, a prohibited practice within the meaning of Section 111.70(3)(a)5 of the Municipal Employment Relations Act, and wherein the City of Cudahy was ordered to cease and desist therefrom and to take certain affirmative action with respect thereto; and further, wherein Local 1801, International Association of Firefighters, AFL-CIO was found not to have committed any prohibited practices within the meaning of the Municipal Employment Relations Act; and no petition for review of said Findings of Fact, Conclusions of Law and Order, with Accompanying Memorandum, having been filed within the twenty day statutory period set forth in Section 111.07(5), Stats.; and no intervening order by the Examiner or the Commission having been issued within said statutory period;
