DIRECTION OF ELECTION

The Labor Organization and the Municipal Employer named above having filed a stipulation with the Wisconsin Employment Relations Commission, requesting the Commission to conduct an election among certain employees of the above named Municipal Employer, pursuant to Section 111.70(4)(d) of the Municipal Employment Relations Act; 1/

NOW, THEREFORE, it is


DIRECTED

That an election by secret ballot shall be conducted under the direction of the Wisconsin Employment Relations Commission in the collective bargaining unit consisting of all full-time and regular part-time social workers and school psychologists employed by Joint School District No. 2, City of Sun Prairie--Towns of Blooming Grove, Bristol, Burke, Cottage Grove, Sun Prairie and York, Dane County and Town of Hampden, Columbia County, but excluding principals, Director of Business and Support Services, Director of Educational Services, Athletic Director, and the school district administrator, who were employed on April 24, 1981, except such employees as may prior to the election quit their employment or be discharged for cause, for the purpose of determining whether the required number of such employees desire to be represented by the Sun Prairie Education Association for the purposes of collective bargaining with Joint School District No. 2, City of Sun Prairie--Towns of Blooming Grove, Bristol, Burke, Cottage Grove, Sun Prairie and York, Dane County and Town of Hampden, Columbia County.

MEMORANDUM ACCOMPANYING DIRECTION OF ELECTION


The Sun Prairie Education Association seeks an election among the remaining professional employees who are not currently included in an existing collective bargaining unit represented by said organization. The School District has stipulated to such an election.


If the residual bargaining unit of unrepresented professionals elects to be represented by the Sun Prairie Education Association, the unit involved herein shall be merged with the existing collective bargaining unit of professional employees. 2/ Terms and conditions of any existing collective bargaining agreement, however, shall not automatically be applied to employees in the residual unit unless collective bargaining produces such a result. 3/
