The above-entitled proceeding having been commenced on September 21, 1982, under sec. 111.07(7), Stats., to enforce the order of the Wisconsin Employment Relations Commission in proceedings entitled Fox River Valley District Council of Carpenters v. Modern Poured Walls, Inc., Case I, No. 28516, Ce-1925, Decision No. 19102; and

The Commission's petition for enforcement having come on for hearing before the court, the Honorable Urban Van Susteren, on November 17, 1982;
