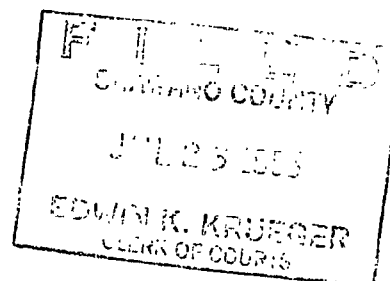


The court having reviewed the record and having had the benefit of the written and oral arguments of the parties; and

decision is affirmed in its entirety.


