WHEREAS, the petitioner, CITY OF AMERY, has filed a petition for review pursuant to the provisions of §. 227.16 of the Wisconsin Statutes, said petition requesting review of the "Finding of Fact, Conclusions of Law, and Order Denying Motion to Dismiss Petition" entered by the respondent, WISCONSIN EMPLOYMENT RELATIONS COMMISSION, in WERC file number "Case 2, No. 34402 MIA-966, Decision No. 22849";

AND WHEREAS, the parties to this action, the petitioner, the respondent, and the Wisconsin Professional Police Association/LEER Division, having consented to the Court reviewing the record as established before the WISCONSIN EMPLOYMENT RELATIONS COMMISSION without additional briefs or argument;


AND WHEREAS, this Court has reviewed said matter and filed its "Decision" dated March 10, 1986:

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. The respondent, WERC, shall interpret the word "population" as used in §. 111.77(8), Wis. Stats., in accord with the definition of "population" as established by §. 990.01(29) of the Wisconsin Statutes, to wit: that population shown by the most recent regular or special federal census.
2. That the respondent, WERC, reverse its order dated August 19, 1985 in this matter.
3. That the motion of the petitioner, CITY OF AMERY, to dismiss the Wisconsin Professional Police Association/LEER Division for binding arbitration involving certain employees of the City of Amery Police Department be granted and that said petition for binding arbitration be dismissed by the WISCONSIN EMPLOYMENT RELATIONS COMMISSION.
