ORDER GRANTING MOTION TO INTERVENE

Green Bay Police Non-Supervisory Bargaining Unit, hereinafter Complainant, having on April 19, 1990, filed a complaint with the Wisconsin Employment Relations Commission alleging that the Mayor and the Common Council of the City of Green Bay, hereinafter Respondents, have committed prohibited practices within the meaning of Secs. 111.70(3)(a)4 and 1, Stats., by refusing to bargain concerning changes in medical insurance coverage including the setting of the amounts of premiums; and Fire Fighters Local 141, International Association of Fire Fighters, AFL-CIO, hereinafter Intervenor, having on July 5, 1990, filed a Motion to Intervene to participate in the complaint proceedings; and Complainant and Respondent having informed the Commission in writing that they have no objection to the Motion to Intervene; and the Examiner being satisfied that the Motion to Intervene should be granted;

NOW, THEREFORE, it is

ORDERED 1/

That the Motion to Intervene filed by Fire Fighters Local 141, International Association of Fire Fighters, AFL-CIO, be, and the same hereby is granted.

Section 111.07(5), Stats.

(5) The commission may authorize a commissioner or examiner to make findings and orders. Any party in interest who is dissatisfied with the findings or order of a commissioner or examiner may file a written petition with the commission as a body to review the findings or order. If no petition is filed within 20 days from the date that a copy of the findings or order of the commissioner or examiner was mailed to the last known address of the parties in interest, such findings or order shall be

- 1/ considered the findings or order of the commission as a body unless set aside, reversed or modified by such commissioner or examiner within such time. If the findings or order are set aside by the commissioner or examiner the status shall be the same as prior to the findings or order set aside. If the findings or order are reversed or modified by the commissioner or examiner the time for filing petition with the commission shall run from the time that notice of such reversal or modification is mailed to the last known address of the parties in interest. Within 45 days after the filing of such petition with the commission, the commission shall either affirm, reverse, set aside or modify such findings or order, in whole or in part, or direct the taking of additional testimony. Such action shall be based on a review of the evidence submitted. If the commission is satisfied that a party in interest has been prejudiced because of exceptional delay in the receipt of a copy of any findings or order it may extend the time another 20 days for filing a petition with the commission.

MEMORANDUM ACCOMPANYING
ORDER GRANTING MOTION TO INTERVENE

Section 111.07(2)(a), Stats., and ERB 2.09 of the Administrative Code permit any other person claiming an interest in a dispute or controversy before the Commission to intervene upon a satisfactory showing of interest in the controversy. 2/ Fire Fighters Local 141, having made application to intervene and demonstrated a satisfactory showing of interest, and neither Complainant nor Respondent objecting to its motion, the Examiner finds it appropriate to grant said motion.
