**JUDGMENT**

---

WHEREAS the Respondents Racine Unified School District (District),  
2220 Northwestern Avenue, Racine, WI 53404, and the Board of Education of Racine Unified  
School District (Board), 2220 Northwestern Avenue, Racine, WI 53404, moved for dismissal of  
this action on the ground that this Court lacks jurisdiction over the subject matter due to failure  
to serve those respondents as required by sec. 227.53(1)(c), Stats., on December 7, 1998;  
Respondent Wisconsin Employment Relations Commission, 18 South Thornton Avenue,  
Madison, WI 53707, did not object to that motion; and the court rendered a decision on that  
motion on May 28, 1999:

Based on the court's May 28, 1999 decision, it is adjudged that:

(1) Respondent's motion to dismiss is hereby granted, for the reasons stated in this  
court's memorandum decision of May 28, 1999, and the August 20, 1998 Petition for Review

in this matter of Racine Education Association, 1201 West Boulevard, Racine, WI 53405, is hereby dismissed; and

(2) Each party is to bear its own costs and disbursements.
